Please follow the FBI Channeling Submission Instructions provided within this document to ensure that your results are processed in a timely fashion. Please complete all of the steps below, and fill in <u>all of the information on the FBI Criminal Report Request form and the fingerprint cards.</u> Failure to provide the necessary information will delay processing time. Please find below

A) Instructions on the process, B) Costs, and C) Additional information.

A) Instructions

- 1) Send in two completed Fingerprint Cards (FD-258)
 - a. Ensure all information is completed on the cards in black ink, and that they have been signed by you and the individual taking the fingerprints
- 2) Complete the FBI Criminal Report Request
 - a. Ensure all notated fields are completed

<u>B) Costs</u> – Total cost will include <u>processing</u> fee <u>plus</u> <u>shipping</u> fee and any <u>additional</u> <u>services</u> (Acceptable forms of payment include check, money order, and credit card (except Discover)

- 1) Processing Fee \$50 per Background Check request, per person
- 2) Shipping Fee select only 1 option. (If you would like both a printed copy and an emailed copy, please select the shipping method for the printed copy, and check the email option from #5-Additional Services.)



ANBCI will not be held responsible for packages requested to be sent out via Regular Mail. A transaction number will be provided, however a refund will not be processed. FBI background check results are deleted from NBCI's system 24 hours after they are printed and mailed. If there is a need to have your background check re-processed, there will be a \$35 charge, which will include ground UPS shipping. NBCI will not send a second copy of the FBI background check via regular mail.

^{**}Same Day Service is restricted to the following conditions: In-store presence before 10am on day of service, pickup of results, and two forms of valid ID. Same day service is subject to the quality of the prints, and will <u>not</u> be available if prints cannot be obtained, if prints are rejected by the FBI, or if the FBI is slow to respond. Refunds will not be processed after services are rendered.





C) Additional Information

- Under DO-556-73, an individual may obtain a copy of his/her FBI criminal identification record, upon request, for the following reasons:
 - > review and correction purposes
 - > to challenge the information on record
 - > To satisfy certain legal requirements such as a requirement for adopting a child
 - > to satisfy a requirement to live, work or travel in a foreign country
 - > and/or other court-related matters
- Processing time Applications are processed 5-7 business days (excluding: Saturday, Sunday, & major holidays) after receipt of documentation. The first business day is the day after we receive your documents. If, however, the application is not filled out correctly, or if the credit card is declined, or if the fingerprints are rejected by the FBI, this may result in a delayed processing time of up to 14 business days, and NBCI having to contact you for additional information before your application can be processed. Our 5-7 day turnaround is not a guarantee, but an approximation of our usual processing time. We will not be held responsible in cases where the FBI is experiencing a slower than usual response time.
- Rejections The FBI may reject the fingerprint card for poor quality. If this is the case, NBCI will process your second card for free. If we do not have a second card, we will notify you that we need one. If the second card is also rejected, you will need to send NBCI additional fingerprint cards, with an additional \$50 payment. Refunds will not be processed for rejections.
- An FBI Approved Channeler
 - May only process requests for a U.S. person (an individual who is a citizen of the U.S. or a lawful permanent resident of the U.S.)
 - That receives the DOCE response with the FBI Seal and Section Chief signature via a pdf attachment, is receiving an <u>authenticated</u> FBI response. **National Background Check, Inc. does receive the authenticated PDF results which can then be Apostilled or Authenticated by the US State Department)
 - Cannot apostille fingerprint search results. If an applicant needs an apostille, they can either apply directly with the FBI for a background check, or the applicant can send the printed authenticated document, returned from National Background Check, to the State Department for further action (emailed copies are not guaranteed to be apostilled by the U.S. Department of State).  - Cannot process a request for employment and/or licensing purposes for jobs within the United States. That type of request should be coordinated and processed via the appropriate state agency (or state police)
- Results returned via Regular Mail (Standard Mail)
 - Can only be sent back to the applicant making the request
 - Cannot be sent to a third party. If the response is being sent to the applicant's attorney, the request must be submitted on the attorney's letterhead with both the individual and the attorney signatures, and must contain a release statement indicating the applicant is aware of and consents to having the results returned to the attorney. This is the only situation for which an application can be returned c/o someone else.





NBCI will not be held responsible for results sent out via regular/standard mail which are lost by the US Postal Service. An FBI transaction number will be provided to the customer, but a refund will not be processed.

Results via Email

- Applicants <u>must include a cell phone number</u> on their application (effective as of 12/28/15)
- Applicants submitting the incorrect cell phone number will be unable to receive the necessary pin to access their document.
- ➤ Cell phone numbers cannot be changed if given incorrectly. The process will need to be restarted, with a new application and \$50 fee.
- ➤ NBCI will not be responsible for charges incurred if text message rates apply (check with your carrier)
- Once results are emailed, you will have 30 days to access your FBI Channeling Criminal Report (Identity History Summary Check). If you wait more than 30 days to view it, the link will no longer be active, and it will also be deleted from our system, per FBI regulations. Once your results are viewed, you will have 24 hours to print or save it to your computer. The link to access your report will be deleted from our system 24 hours after viewing.
- **Disputing information on the Background check** The research for results are completed by the Federal Bureau of Investigation (FBI). You may request a copy of your own identification record to review it or obtain a change, correction, or an update to the record. The information reported on this form may be disclosed pursuant to your consent, and may also be disclosed by the FBI without your consent pursuant to the Privacy Act of 1974 and all applicable routine uses. If you are not a US Citizen or a permanent resident, you must make your request directly to the FBI. If an apostille is needed, NBCI receives authenticated FBI PDF results, with the FBI Seal and Section Chief signature, which the applicant can then send to The State Department to be apostilled.





- Complete all required fields. (If a required field is left blank, the fingerprint card may be immediately rejected without further processing.)

 The required fields for hard copy fingerprint cards are: originating agency identifier number date of birth place
 of birth name sex fingerprint impressions any applicable state stamp Other (race, height, weight, eye color, hair color)
 - criminal fingerprint cards also require an arrest charge and date of arrest.
 - * civil fingerprint cards also require a reason fingerprinted and date fingerprinted

Do not use highlighters on fingerprint cards.
Do not enter data or labels within 'Leave Blank' areas.
Ensure the 'Reply Desired' field is checked when applicable (criminal only).
Ensure fingerprint impressions are rolled completely from nail to nail.
Ensure fingerprint impressions are in the correct sequence.
Ensure notations are made for any missing fingerprint impression (i.e. amputation).

Do not use more than two retabs per fingerprint impression block.
Ensure no stray marks are within the fingerprint impression blocks.
